THE WIND POINT LIGHTHOUSE

To assist navigation around the point into Racine harbor, the Wind Point Lighthouse began functioning in 1860 with Fresnel lens, Its light could be seen for 19 miles. At 108 feet, it is one of the tallest and oldest lighthouses still serving navigation on the Great Lakes, its fog horns. which last sounded in 1964, could be heat for 10 miles. In recognition of the key role this lighthouse has played in the maritime history of Racine County, It was placed on the National Register of Historic Places in 1964. In 1997, the National Park Service awarded ownership of the property to the Village of Wind Point Lighthouse Guard still maintains the light as a public navigation aid.
